Harford and Cecil County Executives, and the counties’ economic development officials, will discuss:

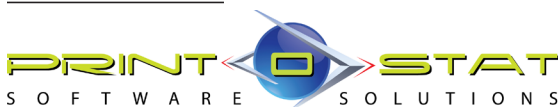

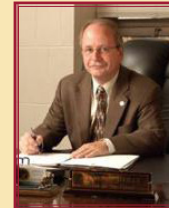
